

# E-mail and Internet Use Good Practice Rules for ICT Use

This Acceptable Use Policy is intended to ensure:

- That young people will be responsible users and stay safe while using the internet and other digital technologies and mobile phones for educational, personal and recreational use.
- That school systems and users are protected from accidental or deliberate misuse that could put the security of the systems and users at risk.

The school will try to ensure that students / pupils have good access to digital technologies to enhance their learning and will, in return, expect the students / pupils to agree to be responsible users. Children will have to accept these rules before accessing their network area.

#### Early years and KS1 code

The school council has developed the following rules to keep all children safe when using ICT in school and at home:

- I will only log in to my own account.
- I will log off my account when I have finished using a computer.
- I will ask permission from a member of staff before using the internet.
- I will only use the internet for school activities and homework using safe sites.
- I will not share any information about myself on the internet.
- If I see something that makes me feel uncomfortable, I will tell an adult.

#### KS2 code

The school council has developed the following rules to keep all children safe when using ICT in school and at home:

- I will only log into my account.
- I will log off my account when I am finished.
- I will ask permission from a member of staff before using the internet.
- I will only use the internet for school activities and homework.
- I will not share personal information online.
- If I see something online that makes me feel uncomfortable, I will tell an adult.
- I will not message anyone I do not know.
- What I write on a computer and online platforms will be polite and responsible.
- I understand that any ICT equipment I bring from home will be checked by a member of staff (including memory sticks).
- I understand that the school may check my computer files and monitor the internet sites I visit.
- I will share no information about school and my friends online.
- I will only use social media apps that are age appropriate
